ANIMAL "FOSTER CARE" AGREEMENT

This Animal "Foster Care" Agreement is entered into between Animal Avengers, a California non-profit corporation ("Charity/we/us"), and the undersigned (the "Caretaker" or "You"). In consideration of the mutual promises in this Agreement, and other good and valuable consideration, the Charity and Caretaker agree to the following terms and conditions, intending to be legally bound:

1. The Animals.

We are delivering the following described animal(s) to you for temporary boarding and foster care (together, the Foster Care") for a period ending upon the adoption of the Animal(s), unless the Animal(s) are returned to us earlier as provided in Paragraph 7 below:

2. The Foster Care.

You will provide the Foster Care in your home at the address at the end of this Agreement, subject to the terms and conditions of this Agreement. Your Foster Care for the Animal(s) will be comprised of, but not limited to, the following:

- Providing daily wholesome food and water
- Providing a clean area for elimination
- Providing outdoor exercise of not less than per day (dogs only)
- Bottle feeding for puppies/kittens, if necessary
- Providing a warm, safe place inside your home, or alternative shelter approved by us in advance, which should include lighting during the daytime if sunlight is minimal
- Administering medicines, if any
- Transporting the Animal(s) to the veterinarian, if necessary
- Transporting the Animal(s) to/from the weekend adoption events and/or arranging for Our pick-up and return
- Socializing and playing with the Animal(s)
- Making sure that the Animal(s) are **always** wearing an Animal Avengers ID tag

3. Veterinary Care.

Whenever possible you will use Animal Avengers approved veterinarians for the Animal(s). The vet(s) closest to where you live that We work with are:

You will telephone of this Charity at to advise her/him of any emergencies involving the Animal(s), for pre-approval of non-emergency veterinary care and also on a basis to advise her/him how the Animal(s) are.

4. Costs and Expenses.

The Charity will pay all veterinary treatment costs that may be incurred for the Animal(s) during the Foster Care; provided that We have given you prior approval by telephone for such treatment, except in the event of a medical emergency in which case you will use your best judgment in the matter. Approved veterinary care from an Animal Avengers veterinarian will be put on Our account at the clinic. Any purchases you make for the Animal during the Foster Care are tax deductible. We can provide you a Receipt For Donation with your proofs of purchase. Remember, you are providing the Foster Care out of your love for animals, and as a volunteer, at no charge to the Charity. The Charity will provide the following for the Animal(s), with the understanding that everything must be returned to Us at the end of the Foster Care:

5. No Liability.

You are not liable to us for any injuries to, illness or disappearance of the Animal(s) arising out of the Foster Care, except if such injuries, illness or disappearance are caused by or arise out of your gross negligence or intentional misconduct. We are not liable for any bodily injury or property damage, losses or injuries whatsoever to you or other persons, or to your or another person's animals and pets, caused by the actions, behavior or health of the Animal(s), or arising out of the Foster Care, except if such damage, losses or injuries are caused by our gross negligence or intentional misconduct.

6. Vaccinations.

We represent that, except for puppies/kittens under months old, the Animal(s) are

7. Returning Animals.

You agree to contact us immediately by telephone in the event that you are no longer able or willing to provide Foster Care to any or all of the Animals. You will continue to care for the Animal(s) for a reasonable period until we are able to come to your home to retrieve any Animal(s) being returned, or until we can accept the return of the Animal(s) from you at our facilities or other designated location. We will notify you by telephone whenever we wish to retrieve any or all of the Animals, whether for adoption into a permanent home, for attendance at an adoption event or any other reason. You will cooperate with us by promptly arranging a mutually satisfactory time for us to pick up any Animal(s) being returned. You may not entrust the care of the Animal(s) to any other person or relocate the Animal(s).

8. Adoption by Caretaker.

In the event that you wish to adopt any or all of the Animals as a household pet(s) for yourself, you must first enter into our Adoption Agreement.

Your decision to adopt should be made before the Animal(s) are taken to an adoption event, wherein they may be promised to another party. (Unfortunately many foster families wait until the Animal(s) are about to be placed to make this critical decision. This had led to countless problems and greatly compromises our ability to successfully place as many animals as possible into loving homes).

9. Loaned Equipment.

Any equipment or supplies loaned to you (covered under Costs and Expenses) will be returned to Us in good, clean condition (subject to normal wear and tear) at the end of the Foster Care period, or whenever We request them. If the foregoing items are lost, stolen or damaged beyond normal wear and tear as a result of your negligence or misconduct, you will promptly replace the items with new items of equal or higher value, or pay Us the replacement price to purchase new items.

10. Entire Agreement; Modifications; Binding Effect.

This Agreement is the entire Agreement between You and Us. Any modification to the Agreement must be in writing, signed by both You and Us. This Agreement binds You and Our respective heirs, executors, representatives, successors and assigns.

All of the information I have provided in the agreement is true and correct.
If any of the information changes, I will advise you promptly.
