OUTREACH PROGRAM/ANIMAL SURRENDER AGREEMENT

Instructions: Please read this Agreement, fill in the blanks, sign it and return it to an Animal Avengers Officer ("Us", "We", "The Group"). Please do not omit any information about your animal; it is vital to have all information so we can find a suitable owner for your animal. Please use a separate Agreement for each animal.

Please give us the animal's vaccination, spaying/neutering and/or other veterinary records.

THE AGREEMENT

In consideration of the mutual promises contained in this Agreement, and other good and valuable consideration, intending to be legally bound, Animal Avengers and the undersigned ("You") agree as follows:

By attending an Animal Avengers adoption, you are giving Animal Avengers the power to place the animal in a suitable, permanent home. Once the animal has been adopted, you agree to irrevocably transfer and relinquish legal, permanent ownership to the Adopter(s). If you decide to leave the animal in our care, or you leave the adoption while it is in progress, you agree to give Animal Avengers complete authority to take whatever actions in our sole judgment are necessary and in the best interest of the animal during the adoption day, as well as after an adoption takes place. During the adoption day, this could include medical treatment in the unlikely event an emergency occurs and we are unable to reach you by phone. At the conclusion of the adoption day, if an adoption has not taken place, you agree to retrieve the animal from the adoption site and continue to foster and care for him/her.

2. Participation Fee/ Adoption Fee.

A refundable participation deposit of **\$50.00 for dogs and \$35.00 for cats** is required to be made at the start of the program and will be held by the Charity until your animal is placed or you notify Us that you no longer want to participate. In the past, individuals have simply abandoned their animal(s) with Us. Unfortunately we do not have a kennel/shelter facility, so such an event creates a tremendous hardship. Therefore, it has been necessary for Us to insist that you provide us with a **\$50.00 Participation Fee** for dogs and a **\$35.00 Participation Fee** for cats that will/can be returned if/when your animal has been adopted.

We require an adoption fee with every adoption. The reason is twofold: (1) we believe that if someone can not afford the adoption fee they may not be able to provide adequate care in the way of food and medical attention; (2) the fee helps support Animal Avengers and the costs associated with running an animal rescue organization. You agree that the adoption fee for your animal will be given to Animal Avengers.

9. No Liability.

We are not liable to you for any losses, injuries, damages, costs, expenses, or liabilities whatsoever, sustained or incurred by you in connection with your surrender of the animal, and our subsequent adoption, foster or other arrangements for the animal.

10. Entire Agreement; Modification; Binding Effect.

This written Agreement contains the sole and entire agreement between Animal Avengers and you, and supersedes any other agreements between you and Us with respect to the subject matter of this Agreement. No modifications of this agreement will be valid, unless made in writing, duly signed by both you and an officer of Animal Avengers. This Agreement will be binding on our and your respective heirs, personal representatives, executors, successors and assigns.

11. Returned Animal.

Animal Avengers has not agreed to foster, board, or otherwise take possession of this animal. You understand and agree that if Animal Avengers successfully places this animal by entering into an Adoption Agreement with a third party adopter ("Adopter"), and the Adopter subsequently returns the animal, Animal Avengers will arrange for the return of the animal to you. If you desire to continue the Outreach Program, you may do so immediately, under the same terms of this Agreement. It is a material condition of the Animal Surrender Agreement that Animal Avengers is acting as an agency in the adoption of this animal, not the adopter or legal guardian, and that you are and continue to be responsible for the animal's care in the event an adoption is not successful.
