Charity is not liable to me for any injuries, damages, liabilities, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with the performance of my volunteer activities for the Charity, unless they are the result of the Charity's gross negligence or intentional misconduct. I will indemnify, defend and hold the Charity harmless from and against any claims, lawsuits, injuries damages, losses, costs or expenses whatsoever, sustained by any companion animal or any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities for the Charity, or my breach of Charity rules, regulation, policies and programs.
4. I understand and agree that the Charity may refuse volunteer applications for any reason.
5. If I will be sheltering or providing foster care or boarding any of Charity's animals in my home or business, I consent to the Charity visiting my home or business from time to time to observe the animals living quarters.
6. I have accurately and truthfully completed this Volunteer Application and Agreement.
7. Any modification to this Agreement must be in writing signed by both parties. This Agreement is binding upon the Charity, me and the Charity's and my respective heirs, successors, assigns, executors and personal representatives.
